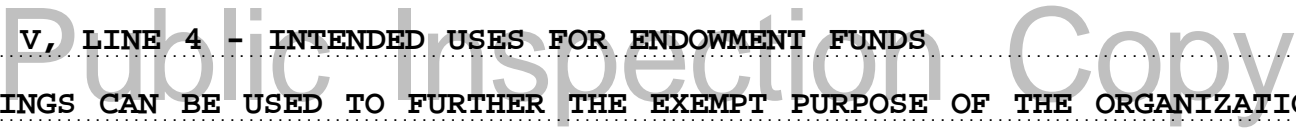

WETLAND EDUCATION, A COMPONENT OF THE LRWP MISSION IS FULFILLED BY PROVIDING AN ARRAY OF FREE WETLAND EDUCATION PROGRAMS FOR ADULTS, CHILDREN, AND SENIORS. THESE INCLUDE COMMUNITY EVENTS FOCUSING ON WETLANDS, THE SEED TO MARSH RESTORATION EDUCATION PROGRAM, STEWARDSHIP, AND CONSERVATION PROGRAMS FOR SCHOOLS AND COMMUNITY PARTNERS. WEEKLY GUIDED HIKES, SENIOR PROGRAMS INCLUDING BREAKFAST ON THE MARSH, YOUTH FIELD TRIPS, AND COMMUNITY SCIENCE PROJECTS ARE OFFERED THROUGHOUT THE YEAR AS WELL. COMMUNITY WETLAND EDUCATION PROGRAMS ARE PRESENTED BY STAFF OR VOLUNTEERS WHO TRAVEL THROUGHOUT THE COUNTY.

LRWP'S FREE WETLAND EDUCATION PROGRAMS HAVE REACHED OVER 125,000 PEOPLE SINCE 2013, OF WHOM NEARLY HALF ARE YOUTH, AND ON AVERAGE 30% ARE FROM LOW-INCOME POPULATIONS. THESE NUMBERS DO NOT REFLECT PASSIVE VISITORS INCLUDING INDIVIDUALS AND FAMILIES PARTICIPATING IN THEIR NATURE RECREATION AT OUR PRESERVES. STAFF WILL CONTINUE EFFORTS TO STRENGTHEN PROGRAMMING FOR THOSE WITH VARIOUS ABILITY LEVELS. LRWP ALSO EDUCATES THE PUBLIC VIA WEBSITE, NEWSLETTER, AND SOCIAL MEDIA. 2022 PROGRAM REQUESTS HAVE RISEN ALONG WITH CORPORATE VOLUNTEER OPPORTUNITIES, AND PUBLIC ATTENDANCE IS ABOVE THOSE SEEN PRIOR TO THE PANDEMIC.
