THE LITTLE RIVER WETLANDS PROJECT (LRWP) IS A NONPROFIT ORGANIZATION WORKING TO RESTORE AND PROTECT WETLANDS IN THE HISTORIC LITTLE RIVER VALLEY, A KEY TRIBUTARY OF THE WABASH RIVER IN NORTHEASTERN INDIANA.
